What are cookies?

Cookies are small text strings exchanged between a server and the web client. They are used for automatic authentication, session tracking, and storing specific information about users accessing the server.

This website uses the following types of cookies:

a) Strictly necessary cookies (Technical cookies)

Cookies that are necessary for the proper functioning of the Website and cannot be disabled in our systems. They are generally installed following actions such as service requests. You can set your browser to notify or block these cookies, although some parts of the Website may be compromised.

b) Performance cookies

Cookies that allow counting visits and traffic sources to measure and improve the Website performances.
